3. HAZARDS IDENTIFICATION:

Not regarded as a health hazard under current legislation.

4. FIRST AID MEASURES:

GENERAL: IN ALL CASES OF DOUBT OR WHEN SYMPTOMS PERSIST, ALWAYS SEEK MEDICAL ATTENTION
